The meeting was called to order at 3:05 pm by Mrs. Penny McCaleb, Chair.

Roll was called to establish a quorum. Present: Hsieh, Morris, Rice, Welch, McCaleb. (Mr. Greenwell arrived at 3:08 pm.)

II. Mrs. McCaleb presented agenda item II - Approval of Minutes of the November 11, 2002, meeting.

Mr. Hugh Rice moved to approve the Minutes of the November 11, 2002, meeting as presented. Mr. Jim Welch seconded. After discussion, motion passed unanimously.

III. Mrs. McCaleb asked Mr. Ken Culver, President, FBD Consulting, Inc. to present agenda item III.

Mr. Culver stated at the last meeting, it was explained that the Metropolitan Library System Pension Plan became effective July 1, 1969. The most recent writing of the Plan was July 1994. Since the Plan was last written many Federal laws and regulations have been changed. In order for the Plan to come into compliance with many of the new regulations, it needed a major rewrite.

The Draft Rewrite was presented at that meeting and subsequently reviewed by the Board. After reviewing the rewrite an error was discovered in the Table of Contents – Definitions section. All definitions were not listed. Mr. Culver provided new Table of Contents pages, which includes the entire definition section listings and the first page of the Pension Plan with today's date as the date of adoption. Mr. Culver asked for questions.

Mr. Rice moved to adopt the Metropolitan Library System Amended and Restated Pension Plan as presented. Mrs. Anne Hsieh seconded. After discussion, motion passed unanimously.

Mrs. McCaleb thanked Mr. Culver for his presentation and hard work. Mr. Culver stated that he has also brought a memo which has a summary of the services provided by the Actuary ~ Mike Bettis and the Consultant ~ Mr. Ken Culver, as well as his biographical profile.

Mrs. McCaleb stated this would be useful information when she reports to the Commission on the Library Retirement Pension Board. She asked if Mr. Culver would attend that meeting of the Commission to answer any questions. Mr. Culver agreed to attend.

There being no further business, the meeting adjourned at 3:15 p.m.
