



Veggie Tacos



Ingredients

- 2 Tbsp. olive oil
- 1 large green bell pepper
- 1 medium yellow onion
- 1 package (8 oz.) sliced mushrooms

Upcoming May Compliance Training -Introduction to Federal Employment Law: Supervisors (REQ)


